Supplying door sets across the industry spectrum, European Wood Products Ltd embarked on an ambitious change of identity in 2003 with a completely new image including a change of trading name to European Doorsets which involved re-branding of the company identity.

Since the name change European Doorsets has gone from strength to strength. Paul Bailey, Managing Director said, *"It was clearly a difficult decision to make given that our original name had served us so well over a sustained period, but nevertheless I am delighted with the results we have achieved since the change and the feedback I have received has been excellent"*.

The privately owned company operates out of a 25,000sq' manufacturing plant using the latest state of the art CNC machinery (*Computer Numerically Controlled*).

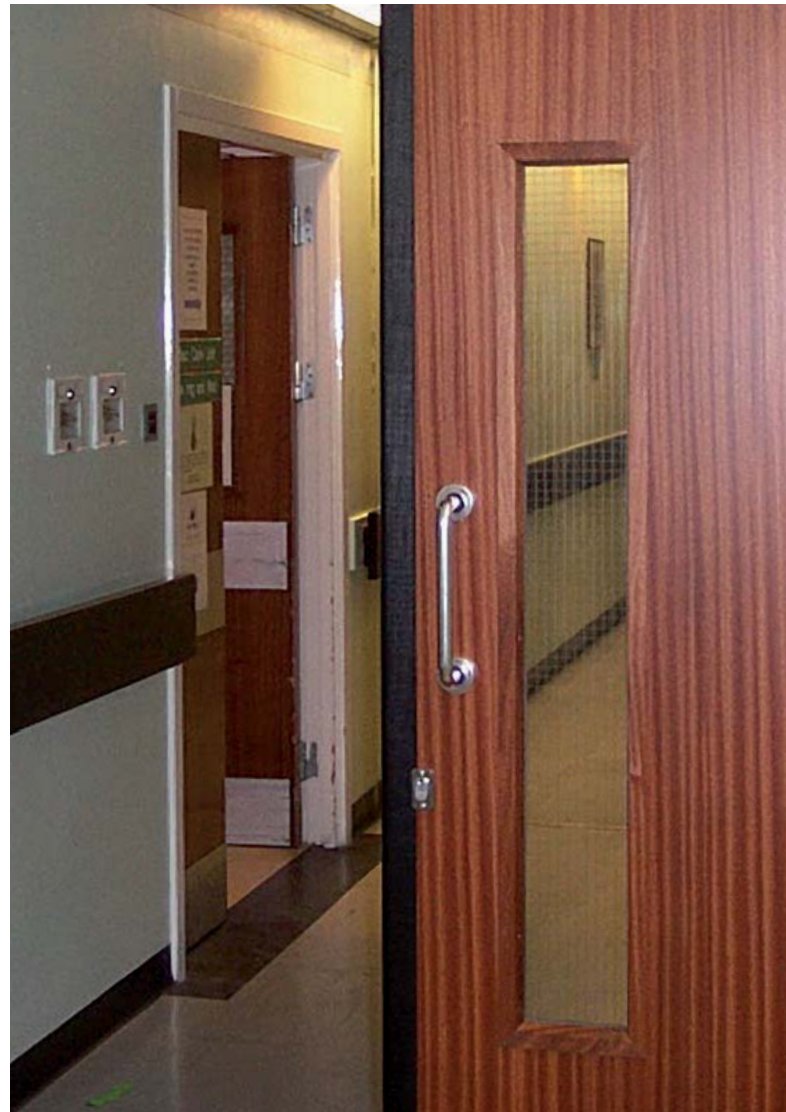
Our standards, our affiliations

It is the policy of European Doorsets to provide its customers with a high quality service and product. Our commitment to this provision is reinforced through our accreditation to ISO 9001: 2000 Quality Standard, ensuring customers have confidence that their needs will be met from receipt of initial enquiry to final delivery.

Case study

Liverpool Women's Hospital. We were delighted to be appointed the door set supplier to the Liverpool Women's Hospital, where a new fertility suite was being constructed known as the Hewitt Centre for Reproductive Medicine.

The specification

Complete door sets were supplied with an Ash veneer finish in painted frames, including the supply of Architrave and all Ironmongery. We serviced for all flush fitting ironmongery including hinges, locks, flush bolts etc. A number of the door sets had to be certified for fire & acoustic performance up to FD60 together with a variety of different vision panel arrangements including Vistamatic privacy panels.
